Cameron County Irrigation District No. 2 Designation of Registered Representative Form Instructions MAY 4, 2024 ELECTION

Please read all applicable laws and rules carefully, including Texas Water Code §§ 58.221, 58.222, 58,223, 58.224, and 58.225, before filling out the Designation of Registered Representative Form.

A landowner who on January 1, 2024 owned less than one acre subject to the District's flat rate assessment, or who is delinquent in the payment of any flat rate assessments can **not** designate a registered representative.

With one exception, a Registered Representative Form MUST BE ON FILE in order to vote. The ONLY exception is when title to land is held solely (only) in the name of one *living* person (an entity such as a corporation or trust is a *legal* person, but is not a *living* person), and that *living* person casts the vote.

The Registered Representative must be A LIVING PERSON WHOSE NAME IS ON THE DISTRICT'S QUALIFIED VOTER LIST:

Who is 18 years of age or older, a United States citizen, not be deemed mentally incompetent by a final judgment of a court, and must not have been finally convicted of a felony unless the sentence is fully discharged or the individual is otherwise pardoned; and

Whose flat rate is current.

Who is a qualified voter is determined as of March 5, 2024. Any change after this date is **not** considered. The list of qualified voters must be posted by the District no later than March 25, 2024.

The attached Designation of Registered Representative Form shall be **RECEIVED** by Cameron County Irrigation District No. 2 ON OR BEFORE APRIL 14, 2024. If mailed, the Designation of Registered Representative Form must be actually received by the District ON OR BEFORE APRIL 14, 2022.

FAILURE TO TIMELY SUBMIT THE DESIGNATION OF REGISTERED REPRESENTATIVE FORM OR PROPERLY COMPLETE THE DESIGNATION OF REGISTERED REPRESENTATIVE FORM SHALL RESULT IN THE INABILITY TO VOTE IN SAID ELECTION.

A QUALIFIED VOTER CAN CAST ONLY ONE (1) BALLOT [Since three (3) Directors will

be elected, and there will be more than three (3) candidates on the ballot, the qualified voter can vote for any three candidates on the ballot—the three candidates who get the most votes will be elected].
