The Board of Directors of Cameron County Irrigation District #2 met in regular session in the office of the District upon the above date at 9:00 a.m.

The following Directors were present: Brady Taubert, William Goad, Buck Rhyner, and Lupe Argullin. Also present were Sonia Lambert, General Manager, and Buddy Dossett, Attorney.

There was no public comment.

A motion was made by William Goad, seconded by Buck Rhyner, and upon unanimous vote, passed to approve the minutes of the regular meeting of October 13, 2022 and the special meeting of October 27, 2022.

The water report was made by William Goad, who reported that Falcon Reservoir contains 477,508 acre-feet of water of the normal conservation 2,646,817 acre-feet. The Amistad Reservoir contains 1,454,414 acre-feet of water of the normal conservation 3,275,532 acre-feet which 31.55% is U.S. total conservation capacity compared to 36.91% this time last year. As of November 10, 2022, District's usable and storage water balances are 42,182.8265 acre-feet. This time last year, usable water balance was 47,004.5581 and storage water balance was 63,129.4662.

The Board reviewed the following subdivision plats and took the following action:

5.1) <u>Aguilera Estate Subdivision</u> – Being 0.758 acre tract out of a 71.44 acres tract and being out of lots 7 and 10, Block 137, San Benito Land and Water Company Subdivision, Cameron County, Texas, according to the map thereof, recorded in Volume 1, Page 6, Mao Records of Cameron County, Texas. – Casa Engineering Civil and Surveying Associates, Inc. Subdivision Review fees have not been paid. No action was taken.

5.2) <u>3C Subdivision</u> – Being a 40.00 acre tract of land comprised of Lots 3, 6, 11, and 14 in Block 129 of the San Benito Land and Water Company Subdivision, in The Concepcion de Carricitos Grant, Cameron County, Texas, according to the map or plat thereof recorded in Volume 1, Page 6, of the Map Records of Cameron County, Texas. – JNH Surveying Co. LLC. This subdivision is located west of Williams Road, north of the police department. Comments were made on the preliminary submitted of the plat. No updated plat has been presented. No action was taken.

The Manager presented a request from Cameron County to purchase 0.009 of an acre tract of land southwest of the intersection of FM 732 (Sherer Rd.) and Pennsylvania Road for \$432.00. The district has its Lateral E-6 pipeline in this tract of land. The Manager will contact Cameron County regarding the relocation of the pipeline. No action was taken at this time.

The Board reviewed and discussed the District's projected water availability for 2022. No action was taken.

The Board entered into Executive Session at 9:18 a.m. pursuant to section 551.072 of the governmental code to deliberate the purchase, exchange, lease, or value of real property; section 551.071 to discuss with attorney pending litigation; and 551.074 to deliberate the appointment, employment, and duties of a joint Assistant General

Manager of the Districts to succeed the current joint Manager upon her retirement: a) Legal issues – i) City of San Benito's refusal to approve plats with District's sign-off paragraph; ii) Employment of Assistant General Manager.

The Board returned to Open Session at 9:34 a.m. and took the following actions: i) no action; ii) A motion was made by William Goad, seconded by Buck Rhyner, and upon unanimous vote, passed to offer Ricardo Martinez the Assistant Manager position, if Cameron County Drainage District #3 agrees, to start in January 2023. Motion carried.
