The Board of Directors of Cameron County Irrigation District #2 met in regular session in the office of the District upon the above date at 9:06 a.m.

The following Directors were present: Sam Simmons, Brady Taubert, William Goad, Buck Rhyner, and Lupe Argullin. Also present were Sonia Lambert, General Manager, Rick Martinez, Assistant Manager, and Buddy Dossett, Attorney.

There was no public comment.

A motion was made by Brady Taubert, seconded by Buck Rhyner, and upon unanimous vote, passed to approve the minutes of the regular meeting of March 9, 2023 and the special meeting of March 30, 2023.

The water report was made by William Goad, who reported that Falcon Reservoir contains 386,709 acre-feet of water of the normal conservation 2,646,817 acre-feet. The Amistad Reservoir contains 1,182,015 acre-feet of water of the normal conservation 3,275,532 acre-feet which 27.16% is U.S. total conservation capacity compared to 34.93% this time last year. As of April 12, 2023, District's usable and storage water balances are 43,162.3818 acre-feet. This time last year, usable and storage water balances were 51,795.7442.

The Board reviewed the following subdivision plats and took the following action:

**5.1)** Rally Credit Union Harlingen No. 1 – 1.14 acres of land out of Lot 2, Security Building Investment Corporation Subdivision, Cameron County, Texas, Recorded in Cabinet 1, Page 109-B, Map Records of Cameron County, Texas. – Moore Land Surveying, LLC. This subdivision is located northeast of the intersection of Frontage Rd. and Camelot Dr. There is no infrastructure located within the subdivision. A motion was made by Brady Taubert, seconded by Buck Rhyner, and upon unanimous vote, passed to approve the plat as presented. Motion carried.

**5.2)** <u>FD Rio Hondo Subdivision</u> – A 1.03 acre tract of land, more or less, situated in the City of Rio Hondo, Cameron County, Texas, out of Blocks 59 and 60, Espiritu Santo Irrigated Land Company Subdivision, according to the map or plat thereof recorded in Volume 2, Page 41, Map Records of Cameron County, Texas. – AEC Engineering, LLC. This subdivision is located on E. Stenger St and just south of N. McCullough St. There is no infrastructure located within the subdivision. A motion was made by Brady Taubert, seconded by Buck Rhyner, and upon unanimous vote, passed to approve the plat as presented. Motion carried.

Ms. Linda Baez requested from the Board that interest be waived to flat rate account #386. After discussion, a motion was made by Buck Rhyner, seconded by Brady Taubert, and upon unanimous vote, passed to deny Linda Baez's request to waive interest to flat rate account #386. However, as per policy, all flat rate and interest due more than 20 years ago will be removed. Motion carried.

The Manager discussed a request by Third Pillar Solar to lease District Reservoirs #1 and #2 for floating solar panel installation. Harlingen Irrigation District #1, La Feria Irrigation District #3, Delta Lake Irrigation, their attorneys and Risk Management Fund have reviewed and signed a contract with Third Pillar Solar. After discussion, a motion

was made by William Goad, seconded by Buck Rhyner, and upon unanimous vote, passed to authorize General Manager Sonia Lambert, Assistant Manager Rick Martinez, and Attorney Buddy Dossett to review and negotiate a contract to install solar panels by Third Pillar Solar in Reservoirs #1 and #2. Motion carried.

The Manager discussed the purchase of a 2018 325 CAT Excavator, serial number 0MBX20429, from Cameron County Drainage District #3 for a total of \$90,000.00. Two separate payments of \$45,000.00 each will be made, with the second payment of \$45,000.00 being paid 60 days after the first payment of \$45,000.00. A motion was made by William Goad, seconded by Lupe Argullin, and upon unanimous vote, passed to approve the purchase of a 2018 325 CAT Excavator serial number 0MBX20429 from Cameron County Drainage District #3 for a total of \$90,000.00. Motion carried.

The District's 2023 1st Quarter Investment report was reviewed by the Board of Directors. The report showed the rate for the account with First Community Bank interest yielded for each month of the quarter and ending value as of March 31st, 2023. A motion was made by Brady Taubert, seconded by Buck Rhyner, and upon unanimous vote, passed to approve the District's 1st Quarter Investment Report as presented. Motion carried.

The Board reviewed the District's projected water availability for 2023. No action was taken.
