The Board of Directors of Cameron County Irrigation District #2 met in regular session in the office of the District upon the above date at 9:00 a.m.

The following Directors were present: Sam Simmons, Brady Taubert, William Goad, Buck Rhyner, and Lupe Argullin. Also present were Sonia Lambert, General Manager, and Buddy Dossett, Attorney.

There was no public comment.

A motion was made by William Goad, seconded by Brady Taubert, and upon unanimous vote, passed to approve the minutes of the regular meeting of January 14, 2021.

The water report was made by William Goad, who reported that Falcon Reservoir contains 486,426 acre-feet of water of the normal conservation 2,646,817 acre-feet. The Amistad Reservoir contains 1,196,608 acre-feet of water of the normal conservation 3,275,532 acre-feet which 45.59% is U.S. total conservation capacity compared to 52.68% this time last year. District's usable and storage water balances as of March 8, 2021 are 64,169.5685 acre-feet. This time last year, usable water balance was 107,178.1539 and storage water balance was 107,773.3891.

The Board reviewed the following subdivision plat and took the following action:

**5.1)** Westway Subdivision Phase 3 – A 27.23 acre tract of land out of and part of the Concepcion de Carricitos Grant, being out of and part of Share 9 as described by the Cause Number 1382, being a portion of Block 191 of the San Benito Land and Water Company Subdivision as depicted by the instrument recorded in Volume 1, Page 6 of the Map Records of Cameron County, Texas, and being a portion of the called 46.97 acre tract of land for Bobby E. and Deborah L. Parrish as described by the instrument recorded in Volume 9040, Page 84 of the Official Records of Cameron County, Texas – Guzman & Munoz Engineering and Surveying, Inc. This subdivision is located off south FM 801 (Ed Carey Dr.), southwest of Nixon Rd. The District's Canal U is located along the eastern boundary of the subdivision. The District owns 100 feet of right-of-way for this canal. Fifty feet are shown on this plat and the other feet are further west and outside the platted area. A motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to approve the plat as presented. Motion carried.

A motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to adopt the following resolution ordering an exclusion hearing to be held:

**WHEREAS**, all of the property described below under "Proposed For Exclusions" is urban property within the meaning of applicable law and has not been within one year previous to this date, used for farming or agricultural purposes; and

**WHEREAS**, the District has no outstanding bonded indebtedness or indebtedness in connection with a loan from an agency of the United States and has authority under *Article 8280-3.2*, *Texas Civil Statutes* to hold a hearing and exclude/include property; and

**WHEREAS**, the property described below under "Inclusions" is agricultural land and can, with installation of additional infrastructure, at the cost of the requestor, be included into the boundaries of the District through substitution of land of equal acreage to be excluded, as allowed through Texas Water Code 58.704; and

**WHEREAS**, it is provided by said statute that the Board of Directors call and hold a hearing whether or not all or part or parts of the urban property shall be excluded/included from or into the District.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that a Hearing be held to determine whether or not all of the urban property described on Exhibit "A" attached hereto and incorporated herein for all purposes, or what part thereof, currently lying within the boundaries of Cameron County Irrigation District No. 2 in Cameron County, Texas, shall be excluded/included from or into the District's boundaries.

Said Hearing shall be held at the offices of the District on the 8th day of April 2021 at 9 o'clock a.m. and may be continued from day to day and from time to time until all persons or their counsel entitled to be heard and who appear at said Hearing have an opportunity to be heard and offer evidence that they so desire.

Notice of this Hearing shall be given by posting a true copy of the full Resolution of the Board of Directors containing a description of all such properties proposed for exclusion/inclusion in the District's website of Cameron County, Texas and in a conspicuous place in the principal office of the District, and by the posting of a true copy of this Resolution containing a description only of each specific subdivision at a location in or near each of the separate subdivisions described below, all of such Notices shall be posted for at least three (3) weeks prior to the date of the Hearing. The date, time, place, and purpose of such Hearing shall also be advertised by publishing Notice thereof one (1) time in one (1) or more newspapers having general circulation in the District at least ten (10) days prior to the date of such Hearing. There, being no railroad right-of-way involved herein, no notice to any railroad company is required.

And, after due discussion, said motion, carrying with it the passage of said Order prevailed and carried by the following vote:

Mr. Abel Suarez, Jr. requested the District's assistance in labor and equipment for the installation of 1375 feet of 15" pvc pipe in Block 105 of the San Benito Land & Water Company Subdivision. A motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to authorize the District's participation in the installation of 725 feet of 15" pvc pipe in Block 105 of the San Benito Land & Water Company Subdivision under the terms set forth in the executed agreement for assistance. A copy of the executed agreement is included in the Supplement to Minute Book #22.

The Manager reported that she sent an email to Baltazar Salazar, Assistant United States Attorney, who the U.S. Army Corp stated would be handling their request to purchase 9.408 acres across the High Line and Low Line Canals, south of U.S. 281 for the construction of the border wall, to inquire about the status of the continuance of the construction plans due to President Biden's order to stop the construction. Mr. Salazar replied stating that negotiations are on pause and the Department of Justice will not pursue acquisition by direct purchase until he receives further guidance by the new administration. This item will be removed from future agendas until the District is contacted by the Department of Justice that construction of the wall will continue and the request is still valid or a new request is received. No action was taken by the Board.

The Manager reported that she sent an email to Baltazar Salazar, Assistant United States Attorney, who the U.S. Army Corp stated would be handling their request to obtain a 4-year temporary easement along the east side of the District's Low Line and in-take channel for a Remote Video Surveillance System, to inquire about the status of the continuance of the construction plans due to President Biden's order to stop the construction of the border wall. Mr. Salazar replied stating that negotiations are on pause and the Department of Justice will not pursue acquisition until he receives

further guidance by the new administration. This item will be removed from future agendas until the District is contacted by the Department of Justice that construction of the wall will continue and the request is still valid or a new request is received. No action was taken by the Board.

The Manager reported that at the Board meeting of February 13, 2020, the Board approved the assistance in labor for the installation of 950 feet of 15" pvc pipe for Armando Salinas in Blocks 52 and 53 of the Hull Subdivision. Since the approval, Mr. Salinas' neighbor, Mr. Julio Lopez, refused the District access to the property. Mr. Lopez then granted Acciona (wind turbines) an easement going across his property where they installed an electrical line 4 feet deep and now require the irrigation to be 4 feet below their line and to be bored. The District does not have boring capabilities to install irrigation lines and therefore the Manager recommended to the Board that they rescind their approval for the District to install the pipeline. A motion was made by Buck Rhyner, seconded by Lupe Argullin, and upon unanimous vote, passed to rescind the authorization to provide assistance to Mr. Armando Salinas in the installation of 950 feet of 15" pvc pipe in Block 52 and 53 of the Hull Subdivision given on February 13, 2020. Motion carried.

The Manager and the Board reviewed the water availability projections for 2021. No action was taken. This item will remain on the agenda for future Board meetings.

The Manager discussed amending the District's Rules and Regulations to increase the waste water fees and also include the water allotment charge to an account if water allocation is in effect. A motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to amend Item No. 12 in the District's Rules and Regulations as follows: 1st acre foot - \$100.00; 2nd acre foot - \$210.00; 3nd acre foot - \$480.00; 4th acre foot - \$900.00; 5th acre foot - \$1,500.00 and if water allocation is in effect, the water allotment will be charged at the rate of two irrigations per acre for the wasted water. Motion carried.

Attorney Dossett was contacted by the bankruptcy attorney who stated that payment of flat rate should have been received. No payment of flat rate for this account has been received to date.
- c) Consolidation of Water Rights TCEQ has not replied to the attorney's questions regarding gps coordinates and the drought contingency plans initially requested by TCEQ for the consolidation of water rights for Cameron County Irrigation District #2 and Cameron County Irrigation District #16. Both the Attorney and Manager are of the opinion to send the coordinates we have on file and wait for a reply from TCEQ.
