The Board of Directors of Cameron County Irrigation District #2 met in regular session in the office of the District upon the above date at 9:00 a.m.

The following Directors were present: Sam Simmons, Brady Taubert, William Goad, Buck Rhyner, and Lupe Argullin. Also present were Sonia Lambert, General Manager, and Buddy Dossett, Attorney.

There was no public comment.

A motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to approve the minutes of the regular meetings of March 17th 2022, March 28th 2022, March 29th 2022, and April 2nd 2022.

The water report was made by William Goad, who reported that Falcon Reservoir contains 433,730 acre-feet of water of the normal conservation 2,646,817 acre-feet. The Amistad Reservoir contains 972,852 acre-feet of water of the normal conservation 3,275,532 acre-feet which 34.93% is U.S. total conservation capacity compared to 43.18% this time last year. As of April 11, 2022, District's usable and storage water balances are 51,795.7442 acre-feet. This time last year, usable and storage water balances were 55,323.59.

Mr. Geary Berkman, C.P.A., was not ready to present the District's 2020 financial audit. No action was taken.

The District's 2022 1st Quarter Investment report was reviewed by the Board of Directors. The report showed the rate for the account with First Community Bank interest amount yielded for each month of the quarter and the ending value as of March 31, 2022. A motion was made by William Goad, seconded by Brady Taubert, and upon unanimous vote, passed to approve the District's 1st Quarter Investment Report as presented. Motion carried.

The Manager informed the Board that Mr. Gustavo Cantu requested to lease 28.60 acres in Blocks 99, 159, and 162 of the San Benito Land and Water Company Subdivision. After discussion, a motion was made by William Goad, seconded by Buck Rhyner, and upon unanimous vote, passed to deny Mr. Gustavo Cantu's request to lease approximately 28.60 acres in Blocks 99, 159, and 162 of the San Benito Land and Water Company Subdivision due to the district previously canceling this lease because of the district's policy that does not allow livestock on district banks along waterways. Motion carried.

A request from Paula Martin to release the block line along the south side of Block 47 and the north side of Block 55 of the San Benito Land and Water Company Subdivision was presented to the Board. William Goad disclosed that he has interest in Block 55 of the San Benito Land and Water Company Subdivision and abstained from discussion and voting. After discussion, a motion was made by Buck Rhyner, seconded by Brady Taubert, with Lupe Argullin and Sam Simmons voting aye and William Goad abstaining, passed to authorize the release of the District's interest in the Block line easement along the north side of Block 55 and the south side of Block 47 of the San Benito Land and Water Company Subdivision, from the intersection of Gamble Road

and Long Lane, west approximately 720 feet to the existing driveway located at 3590 Gamble Road, San Benito, TX, with the requestor assuming all costs associated in the release and a survey of the area to be released. Motion carried.

It was noted that the District is only releasing its interest and the requestor would still need to get authorization from the underlying owners for the section released.

The Manager discussed possibly amending the district's policy regarding violation of out of district yard water use, to allow possible permanent loss of the yard during watering privilege for continued use during a drought or at any other time when not authorized. After discussion, a motion was made by Buck Rhyner, seconded by William Goad, and upon unanimous vote, passed to adopt a yard water violation policy for out of district users, that would allow a possible permanent loss of the yard watering privilege for continued use during a drought or at any other time when not authorized. Motion carried.

The Manager discussed the district's 2022 projected water availability. No action was taken.

The Board entered into Executive Session at 9:49 a.m. pursuant to section 551.072 of the governmental code to deliberate the purchase, exchange, lease, or value of real property; section 551.071 to discuss with attorney pending litigation; and 551.074 to deliberate the appointment, employment, and duties of a joint Assistant General Manager of the Districts to succeed the current joint Manager upon her retirement: a) Legal issues – i) City of San Benito's refusal to approve plats with District's sign-off paragraph; ii) Acquisition of Right-of-Way by the State of Texas over District's High Line and Low Line Canals for border wall; iii) Employment of Assistant General Manager.

The Board returned to Open Session at 10:06 a.m. and took the following actions: i) no action; ii) A motion was made by Brady Taubert, seconded by Buck Rhyner, and upon unanimous vote, authorized the conveyance of an easement to the U.S. Army Corp of Engineers, from the existing IBWC levee west of the district's pumping plant, over the high line and low line canals and south to the levee on the east side of the pumping plant for the construction of the border wall for Homeland Security, provided the construction did not impede or reduce the flow. Motion carried. A copy of the easement and map are included in the supplement to Minute book #22; iii) no action.

A motion was made by Buck Rhyner, seconded by Brady Taubert, and upon unanimous vote, passed to approve the following bills:
