The Board of Directors of Cameron County Irrigation District #2 met in regular session in the office of the District upon the above date at 9:00 a.m.

The following Directors were present: Brady Taubert, Buck Rhyner, Lupe Argullin, Zac McLemore, and M.R. Garcia II. Also present was Ben Escobar, Assistant Manager, Carla-Marin, General Manager, and Buddy Dossett, Attorney.

There was no public comment.

A motion was made by Buck Rhyner, seconded by M.R. Garcia II, and upon unanimous vote, passed to approve the minutes of the regular meeting of May 8, 2025.

The water report was made by the General Manager who reported that Falcon Reservoir contains 297,531 acre-feet of water of the normal conservation 2,666,203 acre-feet. The Amistad Reservoir contains 642,082 acre-feet of water of the normal conservation 3,226,704 acre-feet which 15.94% is U.S. total conservation capacity compared to 19.37% this time last year. As of June 18, 2025, the District's usable and storage water balances are 30,633.4666 acre-feet. This time last year, usable and storage water balances were 16,670.5309 acre-feet.

The General Manager presented the quote received from Lewis Electric for the Unit #1 pump that needs to be repaired. The quote received showed a cost of \$14,240.60 in materials and \$6,765.00 in labor totaling to the amount of \$21,005.60. A motion was made by Buck Rhyner, seconded by Zac McLemore, and upon unanimous vote, passed to approve the quote of \$21,005.60 from Lewis Electric for the repair of the Unit #1 pump.

The General Manager presented a Memorandum of Understanding between Cameron County Irrigation District #2 and the Dossett Law Office outlining the District's and Attorney Dossett's agreed upon standard of work. A motion was made by Zac McLemore, seconded by Buck Rhyner and upon unanimous vote, passed to approve the MOU and signed. After a discussion, the motion was unanimously carried.

The Board discussed the District's water availability for 2025. The Assistant Manager reported that the District received an allocation of 8,287.7066 ac-ft. and explained that with this allocation the District's balance allows for another "Top Off" allocation. A motion was made by Zac McLemore, seconded by Buck Rhyner, and upon unanimous vote passed to approve a "Top Off" allocation.

There was nothing to discuss in Executive Session. Accordingly, no executive session was held.

A motion was made by Buck Rhyner, seconded by Lupe Argullin, and upon unanimous vote, passed to approve the following bills:

- d) Federal Funding through FEMA for the damage caused by the March 27, 2025 flood. The General Manager reported that the District has reported a total of \$35 million in damages. The District is now waiting on FEMA to determine if or when the funds will be disbursed.
- e) Total attested acres for the TDA grant. The General Manager reported that as of June 18, 2025, the total acres attested for the year 2023 was 35,917.99 acres and for the year 2024 was 35,866.52 acres. The District is still issuing Attestation forms for applicants that submitted their applications before the deadline but were missing their documentation that the TDA has requested.

The Attorney had nothing to report; therefore, no attorney reports were discussed.
