

# Cameron County Irrigation District No. 2

## Designation of Registered Representative Form Instructions

**MAY 2, 2026 ELECTION**

**Please read all applicable laws and rules carefully, including Texas Water Code §§ 58.221, 58.222, 58.223, 58.224, and 58.225, before filling out the Designation of Registered Representative Form.**

**Eligible voters and eligible voter entities were determined as of March 3, 2026 at 5:00 Pm.** Any change after this date will **not** be considered. The list of eligible voters and eligible voter entities must be posted by the District no later than March 23, 2026. A landowner who on January 1, 2026 owned less than one acre subject to the District's flat rate assessment, or who was delinquent in the payment of any flat rate assessments as March 3, 2026 at 5:00 pm **cannot** designate a registered representative.

**A Designation of Registered Representative Form must be on file with the District in order for a voter to cast a ballot on behalf of a land ownership interest.** The only exception is when title to the land is held solely in the name of one living person and that person personally casts the vote. Entities such as corporations, partnerships, trusts, estates, and any form of joint ownership must designate a registered representative to vote on behalf of the ownership interest.

**Only one Designation of Registered Representative may be filed for each land ownership interest.** If multiple designations are submitted, the most recently dated valid designation received by the District prior to the filing deadline will be Designated the Registered Representative.

**A Registered Representative designated to vote on behalf of a landowner must be** a living person who is at least 18 years of age, a citizen of the United States, not declared mentally incompetent by final court judgment, and not finally convicted of a felony unless the individual's sentence has been fully discharged or the individual has been pardoned. The land ownership interest represented must also be current with all district flat rate assessments as of March 3, 2026.

The attached Designation of Registered Representative Form **MUST BE RECEIVED** by Cameron County Irrigation District No. 2 **ON OR BEFORE APRIL 13, 2026**. If mailed, the Designation of Registered Representative Form must be actually received by the District **ON OR BEFORE APRIL 13, 2026**.

**FAILURE TO TIMELY SUBMIT THE DESIGNATION OF REGISTERED REPRESENTATIVE FORM OR PROPERLY COMPLETE THE DESIGNATION OF REGISTERED REPRESENTATIVE FORM SHALL RESULT IN THE INABILITY TO VOTE IN SAID ELECTION.**

**A QUALIFIED VOTER CAN CAST ONLY ONE (1) BALLOT**

**Since two (2) Directors will be elected, and there will be more than two (2) candidates on the ballot, the qualified voter can vote for any two candidates on the ballot—the two candidates who receive the most votes will be elected**

\*\*If ownership is vested in more than one individual (that is, there are multiple owners), this form must be signed by ALL owners.

\*\*If ownership is vested in a partnership, this form must be signed by ALL partners.

\*\*if ownership is vested in a limited partnership, this form must be signed by the General Partner.

\*\*If ownership is vested in a corporation or other entity, this form must be signed by an authorized officer or representative of the corporation or entity.
